Purpose of the Orlando Dog Training Club, Inc.

According to Article I, Section 1 of the By-Laws adopted December 1972, the objectives of the Club shall be:

- To conduct obedience trials and sanctioned matches under the rules of the American Kennel Club.
- To devote all profits accruing to the Club to the above purposes or to make specific bequests to such charitable or civic organizations as shall be approved by a majority vote of those in attendance and voting at a Club meeting, Special Club meeting, Board meeting or Special Board meeting and under no circumstances to pay salary, fee, commission or dividend to any member. Authorization for the payment of current expenses shall be voted on at any of the above meetings.
